

4. Precautions

Please come early because the number of receptionists will be reduced after 17:00. Please do not request a procedure just before the closing time of business. Please submit the radiation work plan and tour application at least one day in advance. Please request radiation measurements of items to be taken out of the radiation-controlled area well in advance.

Radiation Reception Desks

1. Basic Information

Location: PF Radiation Reception Desk --- PF Light Source Building, 1F

AR Radiation Reception Desk --- KEKB Control Building, 1F (right outside of the main entrance)

Business hours: 8:30-18:00 on weekdays, weekends, and holidays (except during summer blackouts)

However, when the PF light source is in operation, PF Radiation Reception Desk is open 24 hours a day.

When the PF light source is not in operation, AR Radiation Reception Desk is open 24 hours a day.
